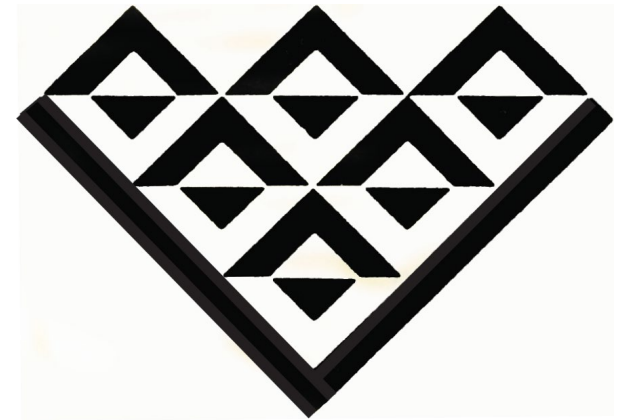

Shipping of Paintings – To be received between August 2-16, 2024 (NO EARLY DELIVERY)

Shipped entries must be received by Aug. 16, 2024. Shipped entries must be prepaid for return shipping, with mailing labels included - container must be adequate for return shipping and postage paid.

Presentation of Entries:

Total image area of painting shall not exceed 36 square inches (6" x 6" / 5" x 7" or smaller). Outside frame size not to exceed 120 square inches. All works must be delivered framed and ready to hang. Wrapped canvas will be accepted without a frame if edges are painted and clean. Each piece must be identified on the back with artist name, address, phone number (number where you can be reached if work is not accepted), title, price and medium. Frames must be undamaged, with hardware and wire in place. NO sawtooth hangers. Paintings delivered chipped, cracked, damaged, dirty or with improper presentation or incomplete information on the back will not be accepted.
